The Hamilton County Board of Supervisors met in regular session on Tuesday, November 22, 2016 at 9:00 A.M. in the Boardroom of the Hamilton County Courthouse, Webster City, Iowa.

- CALL TO ORDER:** Called to order by Chair Doug Bailey.
- PLEDGE OF ALLEGIANCE:** The Board led the Pledge of Allegiance.

- AGENDA:** **Motion Young, second Sweedler to approve the agenda. Motion carried.**
- MINUTES:** **Motion Sweedler, second Young to approve the minutes of the November 8, 2016 meeting. Motion carried.**

- AGREEMENTS/CONTRACTS:** **ACCURATE CONTROLS, INC: Motion Young, second Sweedler to approve purchasing a three year silver plan for maintenance and service at a cost of \$61,828.40. Motion carried,**
- SAFRAN: Motion Sweedler, second Young to approve a maintenance and support agreement in the amount of \$6,231.00. The agreement is in effect from February 1, 2017 through January 31, 2018. Motion carried.**
- FM CONTROLS, INC: Motion Young, second Sweedler to approve a preventative maintenance agreement for two years for the automation systems at the courthouse. Motion carried.**
- G6PS LITTLE WALL GROUP LLC: Motion Sweedler, second Young to cancel the power purchase agreement with the G6PS Little Wall Group LLC. Motion carried.**
