

**PROCEEDINGS OF THE HAMILTON COUNTY BOARD OF SUPERVISORS
REGULAR MEETING**

The Hamilton County Board of Supervisors met in regular session on Tuesday, June 25, 2019 at 9:00 A.M. in the Boardroom of the Hamilton County Courthouse, Webster City, Iowa. Unless otherwise noted, all actions were approved unanimously.

- CALL TO ORDER:** Called to order by Chair Doug Bailey.
- PLEDGE OF ALLEGIANCE:** The Board led the Pledge of Allegiance.
- MEMBERS PRESENT:** Dan Campidilli, Rick Young, and Doug Bailey.
- OTHERS PRESENT:** Pat Powers, Doug Timmons, Shelby Kroona, Rob Swenson, Tyler Swenson, Kent Krause, Jamey Whitney, Alissa Schliff, Paul Handsaker, Dave Hinderaker, Brian Lammers, Anne Blankenship, and Kim Schaa.
- PUBLIC COMMENT:** Dave Hinderaker and Paul Handsaker spoke to the Board concerning the possibility of the County downgrading one-mile Zeigler Ave in section 1 of Scott Township. The Board responded they were not aware of any plans to downgrade the road.

Conference Center: Hiring of Wendi Dinsdale as part-time on call kitchen staff at \$10.00 per hour.
- SALARY CERTIFICATION:** **Motion Young, second Campidilli to approve salary and wage certifications for FY'20 as filed by department heads.**

CONTRACTS:** **TEAMSTERS LOCAL NO. 238: Motion Campidilli, second Young to approve a four-year contract with Teamsters Local Union No. 238.**

CENTRAL IOWA COMMUNITY SERVICES SOU: Motion Campidilli, second Young to approve SOU's with CICS for the positions of Quality Assurance Officer, Administrative Support, and Service Coordinator.

YOUR, INC. LEASE: Motion Campidilli, second Young to approve a ten-year lease with YOUR, Inc. for office space at Shashi Station. The rent will be \$2,088 per month for the first five years.

PRESENTATION: Kent Krause from Pinnacle Environmental Compliance gave an explanation of the project and went through how the master matrix for this site was scored. This site is located in Section 19 of Rose Grove Township and is two new deep pit swine finisher confinement buildings that will house 5,400 head. This site meets or exceed the Master Matrix minimum score.
